- (b) Wisconsin Statute Section 19.85(1)(f) for the purpose of possible discussion and action on Village Manager vacancy and the financial, medical, social or personal histories or disciplinary data of specific persons, preliminary consideration of specific personnel problems or the investigation of charges against specific persons except where par. (b) applies which, if discussed in public, would be likely to have a substantial adverse effect upon the reputation of any person referred to in such histories or data, or involved in such problems or investigations.

The Board may thereafter reconvene in open session pursuant to Wisconsin Statute Section 19.85 (2) to report the results of the closed session and consider the balance of the Agenda.
